This will be implemented through a series of outbound calls from Workers' branch staff.

"We have had a good history of penetrating our field of membership with our insurance product offerings," said Doug Petersen, EVP, Workers' Credit Union. This new product will provide an important new service to our members and should deliver a great new stream of income to the credit union."
